Honourable Sir.

Most of the time solution of many complex problems is found hidden in the problem itself. All dairy business entrepreneurs in India are facing unresolved chronic problem of intermixing of buffalo milk with cow milk and its further dilution with added water. It results in causing around 20% cost of raw milk as hidden loss amounting to billions of rupees every year to ethical dairy business entrepreneurs in India besides encouraging unabated adulteration of raw milk with hazardously harmful adulterants or preservatives by unethical middlemen now dominating the milk procurement value chain.

Under the conditions now prevailing in India we can only trust our **KAMDHENU'S i.e. buffaloes and cows** because these natural creatures can neither dilute/adulterate their own milk nor manipulate S.N.F/Fat ratio of their natural milk themselves. Latest research findings indicate that pure pasteurized buffalo or cow milk having natural S.N.F/Fat ratio is more healthy, nutritional and microbiologically safe for human beings.

Our Mission with the help of our mission associates supporting our mission activities in India has recently launched a pilot project here at Chandigarh (India) to demonstrate scientifically logical and practically viable solution of a wide spread menace of adulteration and manipulation in milk so as to double the income of ethical commercial dairy farmers now struggling hard for survival of their dairy business.

Our Mission coordinator living in sector 18 Chandigarh on behalf of consumer self-help group has entered into agreement with a commercial dairy farmer of a nearby village in Punjab. He visits his dairy farm daily to get milking done in his own presence by taking specified sanitary precautions. He carries with him required number of clean/sanitised glass bottles and milk is filled/ sealed in those bottles on the spot in the milking parlour itself.

Milk in sealed bottles is then cooled to temperature below 4 degree Celsius and pasteurised by using innovative milk pasteurising/sterilising machine designed by our Mission associate in Canada and got manufactured in India by our Mission associate in India. Whole milk of natural composition is pasteurised or sterilised in that machine having shelf life of two/three weeks for pasteurised milk (under refrigeration) and more than one year for sterilised milk when stored at cool dry place even at room temperature.

Volunteers of Rainbow International community services and International Improvement Mission provide free expert guidance and consulting services to commercial dairy farmer and self-help consumer group members living in sector 18 Chandigarh to scientifically process and distribute that pure milk among themselves without involvement of any middlemen in the value chain.

Pilot project is successfully working for the last one month and appreciably benefitting concerned commercial dairy farmer who is getting most remunerative price for the milk produced at his dairy farm (Highest among dairy farmers selling their raw milk to commercial dairy plants in Punjab).

Consumer group members are also very happy because 100% pure pasteurized whole milk of natural composition is reaching on their door step at globally competitive but reasonable price.

We extend cordial invitation to selfless political leaders, honest administrators and prudent dairy professional experts of our motherland to watch live demonstration of our humble pilot project initiative and extend their support to our Mission in creating direct fly over link between milk producers and consumers for replicating and extending this milk producer friendly consumer friendly country wide campaign against adulteration in divine nectar called milk. Subject: Let us double the income of dairy farmers of India in one year with professional Innovations and management interventions

Respected Sir

Kindly refer to your communication dated 19th February on the subject addressed to Managing Director N.D.D.B., Director Dairy Development Punjab, Director National Dairy Research Institute Karnal and a copy endorsed to our Mission.

Premier dairy institutions of our motherland can definitely help all dairy plants in India to increase basic bench mark price of milk by more than Rs.100/Kg fat by evolving arithmetically accurate and scientifically logical solution of age old complex unresolved problems relating to milk purchase transactions in India using prevalent 60:40 two axis formulae. Under prevalent system, milk producers supplying pure milk get 20% to 30% less than actually due price. However unethical milk producers or middlemen in the value chain who sell manipulated mixed milk (buffalo milk+ cow milk+ added water) get relatively 20% to 30% more because due to dilution and manipulation added water becomes milk and gets paid as milk.

Digital hydro analysis of milk purchase transactions of a premier dairy institution (MILKFED Punjab) for the month of December 2017 recently carried out by our Mission associates, indicate hidden loss of Rupees 7.61/Kg (Rs 1,63,76,480/day) only due to dilution and manipulation (assuming no adulteration other than added water). As per our survey and research findings, no dairy plant in India is immune to such losses and total amount of these losses on all India bases would work out as an astronomical figure. We have authentic documentary/video evidence to substantiate our claims and contentions mentioned above. We can share the same with authorized representatives of Premier dairy institutions of India who are willing to highlight and resolve this core issue for the benefit of needy milk producers, innocent consumers and ethical dairy business entrepreneurs of India.

We have recently conducted a complementary interactive training program for a spear head team of concerned executives of MILKFED Punjab to inspire and motivate them so that they may acquire required skills to accomplish following objectives with simple implementation tasks and result oriented management interventions.

- How to work out net loss (Rs./Kg.) due to dilution and manipulation in milk purchase transactions using digital analytical technique and "APNI DAIRY" software available on our website: http://www.apnidairy.com/ (free download)?
- 2. How to modify prevalent milk billing system (60:40 two axis formulae for purchase of buffalo milk and ½ and 2/3rd empirical formulae for purchase of cow milk and changeover to 100 % accurate scientifically logical C.L.R. based formulae for calculating S.N.F.=C.L.R./4+0.2xFat+C.L.R./100 to work out true worth of B.M., C.M. or mixed milk (diluted or undiluted) for completely eliminating menace of hidden losses in milk purchase transactions due to dilution and manipulation?
- 3. How to purchase absolutely pure milk without any adulteration using five simple tests that can be conducted on the spot by milk procurement staff under prevalent field conditions?
- 4. How to bring in 100% transparency and accountability in milk purchase/local sale transactions and introduce system of cashless transactions (from milk producers to milk plant)?
- 5. How to process, pack and market 100% pure cow milk or 100% pure buffalo milk at B.M.C. Level using solar/biogas energy (home pasteurisation method) attaining she life of two/three weeks (under refrigeration) and market the same as "VERKA" pasteurized milk in nearby urban markets or as mid-day meal supplement for school children under the program being Sponsored by G.O.I.?

MILKFED Punjab with the help of spear head team trained by us can definitely eliminate prevailing hidden loss of Rs.7-8/Kg. in milk purchase transactions now being suffered by all their district cooperative Milk unions and easily increase basic milk purchase price by more than Rs.100/Kg. fat without any negative impact on their bottom line results. Besides it capacity utilisation of their dairy plants will improve by 20%-30% due to procurement of undiluted raw milk meeting with international quality requirements.

ALTERNATIVE SUGGESTION FOR PERMANENT SOLUTION OF UNRESOLVED COMPLEX PROBLEM:

We would like to suggest that Government of India may introduce a legislation to impose complete ban on purchase or sale of mixed milk in the country. Raw or pasteurized buffalo milk must contain not less than 6.50% Fat and 8.84% S.N.F. (C.L.R. not less than 29) and raw /pasteurized cow milk must have minimum 3.50% Fat and 8.50% S.N.F. (C.L.R. not less than30). Likewise goat milk, camel milk or milk of any other animal should be traded separately (without any intermixing or dilution with added water) as per specified standards fixed by Government of India.

Our Mission addressed a communication to Honourable President of India on the correlated subject and received acknowledgement P-1/C 84598 dated 7 October 2004, informing us that our communication has been forwarded to Ministry of Agriculture for necessary action. Government of India has been investigating the matter vide File No. 22-08/2010 for the last many years.

During this period we were invited to make a presentation at N.D.R.I Karnal, Krishi Bhavan New Delhi and Dairy conference held at NDRI Kanal. Video copies of our presentations are available on our website http://www.apnidairy.com

kindly forward copy of the comments received from premier dairy institutions in response to your communication mentioned above to our Mission. We would also suggest that Government of India may constitute a committee of dairy experts from premier dairy institutions and arrange their interactive meeting with us here in our Mission office at Chandigarh (on a mutually convenient date before 30.04.18). We shall try our best to supply required clarifications/ additional information to the expert committee members besides providing to them live demonstration of our innovative green technology to pasteurize/sterilise milk (meeting with international quality requirements relating to purity of contents, microbiological safety and shelf life) at a nominal recurring cost using solar energy.

We are absolutely confident that with our collective professional wisdom and resources available with premier dairy institutions of our country, we can easily double the income of dairy farmers of India with in a period of next one year through professional innovations and scientifically logical management interventions.

AGREEMENT

This agreement is made at Chandigarh on the 31st January, 2019 between Sh. Bant Singh resident of village: Mullanpur, District: Ropar, Punjab (hereinafter referred to as "COMMERCIAL DAIRY FARMER") of the one part and Sh. Ashok Kumar Arora, Sector Coordinator Rainbow International Community Services (India) resident of House No. 1103 (G.F.), Sector- 18-C, Chandigarh- 160018, (hereinafter referred to as the "SECTOR COORDINATOR") of the other part.

Whereas **COMMERCIAL DAIRY FARMER** is in the business of producing quality milk, has agreed to sell the same, on the mutually agreed terms and conditions, to the **SECTOR COORDINATOR**, who represents self-help consumer group living in sector 18 Chandigarh.

International Improvement Mission being a voluntary organization established by N.R.I. dairy professionals living in Canada/U.S.A. and having its registered office in sector 18 Chandigarh has agreed to provide free expert guidance and consulting services to both the parties.

Whereas both the parties after due discussion regarding production of quality milk, pasteurizing it and then supplying it to the registered members of Rainbow International Community Services living in sector

18 Chandigarh. They have for the said purpose mutually agreed on the following terms and conditions:

1. That the following shall be deemed to form and be construed as part of this Agreement:-

All documents mutually agreed from time to time by both the parties in regard to the smooth working of the arrangement as detailed below for the production and handling of milk till it reaches the consumer in its purest form.

- 2. That the COMMERCIAL DAIRY FARMER has agreed to supply, as per mutually agreed time schedule, 100% pure chilled Buffalo whole milk of natural composition (below 4 degree Celsius) to the SECTOR COORDINATOR @Rs. 60/- (Rupees Sixty only) per Litre, in glass bottles containing 500 ml. milk each; during the period from 1st February, 2019 to 31st July, 2019.
- 3. That the COMMERCIAL DAIRY FARMER has agreed to ensure perfect sanitation and hygiene at his dairy farm especially at the place of milking. He will further ensure that udder of each buffalo is properly washed, cleaned and sanitized with sanitary towel before milking. Person milking the buffaloes will keep his/ her nails cut, wash hands with soap before milking. Milking pail would be of stainless steel and properly cleaned/ sanitized before use.
- 4. That the **COMMERCIAL DAIRY FARMER** has agreed to supply pure milk produced only by healthy buffaloes kept by him at his dairy farm without use of antibiotics or hormone injections and free from any kind of adulterants or preservatives.

- shall place a minimum order of 10 litters/ day of milk to be supplied and the ordered quantity shall in no case exceed more than 100 litres/ day.
- 6. That the SECTOR COORDINATOR shall ensure that the payment of total quantity of milk received by him during a particular month is credited into specified bank account of the COMMERCIAL DAIRY FARMER before 10th of subsequent month. Penalty @ Rs. 100/- (One Hundred) only per day would be applicable for any delay in payment after the specified period mentioned above.
- 7. That both the parties can terminate the agreement by giving a minimum notice of 30 days in writing.
- 8. That the International Improvement Mission and its associate M/S Innovative Business Improvements Private Limited Chandigarh as Mentors have agreed to provide free guidance and consulting services to both the parties and to act as a guide for the production, procurement, pasteurization, packing, testing and distribution of quality milk. The Mentors or their representatives would be fully authorized to monitor all parameters of raw milk quality.
- 9. MENTORS can periodically conduct required tests relating to purity of contents, microbiological safety and shelf life of raw milk (Fat%, S.N.F. %, C.L.R., Khoa test, paneer test, Iodine test, litmus test and M.B.R. etc.) in the presence of both the parties. In case any dilution with added water or adulteration is detected in any samples tested during a particular month penalty @ Rs.10/ Litre on the entire quantity of milk supplied by the COMMERCIAL DAIRY FARMER to the SECTOR COORDINATOR during that month shall be deducted from the payment to be made to him in the subsequent month.
